SVAM Education Outreach Programme

Over the last five-six years we have added Workshops in schools and Master Classes to our regular activities, taking advantage of the expertise of our visiting musicians. Last season we received a major grant from a Charitable Trust which wishes to remain anonymous. The grant was earmarked to benefit children of 16 and it enabled us to organise a series of recorder workshops with Piers Adams jointly with Essex and Suffolk schools, and inviting children and their families to come to the special concert by Red Priest. The grant also funded piano hire for a special children's concert on 1 November, offering a platform for young advanced musicians from our local area. In the forthcoming season we will be putting on another Young Musicians' Concert on 5 March 2017, and we are looking for an opportunity to organise another primary school workshop.
